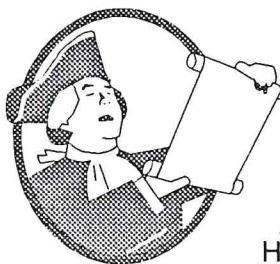

#### UPDATE: 29TH MIDYEAR TUTORIAL - NASHVILLE, TN

#### RECERTIFICATION

The American Osteopathic Association/American Osteopathic Board of Pathology has not issued a final disposition of the issue - Recertification. It is expected that this may possibly be resolved by the July AOA Board of Trustees meeting in Chicago.

A resolution was proposed to the AOA Bureau of Osteopathic Specialists at its January meeting by the American Osteopathic Board of Pathology, which among other things, provided for an alternative pathway to recertification without examination. This resolution was returned to the AOBP for reconsideration.

In further action, the Bureau moved "that language be drafted to amend the Bureau Handbook, Article IX, D. Recertification Process, to require examination in all cases for recertification."

A meeting of the full Bureau is scheduled for June 11, 1995.



## Bylaws

Within the next month, a copy of the proposed bylaws will be sent to the Active members for review at the General Meeting to be held October 15, 1995 in Orlando, FL at the time of the AOA Convention.



These will be sent in accordance with the present bylaws, i.e., at least 45 day prior. . . It is suggested that you bring them with you to the October meeting for reference, at which time they will be voted upon for acceptance.

There has been a significant addition to the categories of the membership. Added, was the category of "Affiliate." This category will provide membership for the allied laboratory professionals, i.e., MT, MLT, HT, cytotechnologists. These health care professionals may not vote or hold office, however, they may be appointed to committees.

With the changes in CLIA '88, medical technologists will be a new presence in the laboratory inspection team. Annual dues (\$35.00 per year) is minimal and laboratory directors are encourage have their eligible staff pursue membership.

For the third time, STANDARDS FOR "MODEL INTERNSHIP ROTATIONS - SPECIALTY TRACK INTERN YEAR" were also submitted. Again, finally, everything was approved! There were some editorial changes made to the standards, however, these were only to have them uniform with other specialty colleges documents.

The significance of this is, that ACGME residents who enter a five-year program will have the first year counted as (and in lieu of) their traditional AOA rotating internship. They will also be eligible to apply to sit for AOA board certification.

**MODEL INTERNSHIP ROTATIONS**  
**SPECIALTY TRACK INTERN YEAR - PATHOLOGY**

The internship must meet both the osteopathic base of a transitional internship experience while still allowing the resident the opportunity for an acceptable fifth year of special competency. The internship, therefore, must be in an institution that has an AOA-approved residency and subspecialty programs in pathology and its subspecialty areas.

A. The program submitted below meets the foundations of an osteopathic internship while providing the osteopathic profession the opportunity to selectively maintain competitive pathology residency and subspecialty training programs. In brief,

1. 4 mos of pathology, 2 mos of anatomic pathology, and 2 mos of clinical laboratory to include hematology, blood banking, chemistry and microbiology.
2. ½ day per week in family practice ambulatory care for 1 year.
3. 3 mos internal medicine, including 2 mos general internal medicine, 1mo clinical hematology.
4. 3 mos of surgery, including 1mo general surgery, 1mo surgical pathology/frozen sectioning, and 1 mo emergency medicine.
5. 1 mo female reproductive medicine, to include GYN pathology and GYN cytopathology and ambulatory GYN (Pap smears, etc.).
6. 1 mo of pediatrics, (inpatient or ambulatory pediatrics)

N.B. > These are abbreviated. Other standards included inspections, etc. If you are in a five-year program and want complete standards, call. . . . Hopefully, these will be fully approved by the AOA in February.
