These will be printed in the AOCP Annual Directory which will be available sometime in March, or earlier, if possible.

The Midyear Tutorial  chaired by D Jeffrey Gray, DO is fast approaching. Dr. Gray has an exciting meeting planned with a fantastic line-up of speakers. It's definitely a "don't miss" program.

The same format as last year will be followed. The Board will meet at 2:00pm on Friday and all college members are welcome to attend. As a reminder, residents pay no registration fee.

Following that, the college will host a one-hour wine and cheese reception with the time to meet old friends and make new ones.

Leave an early wake-up call for Saturday morning! Begin with a continental breakfast at 7:00am and begin the morning sessions. We will close for the day at about 1:30pm so you'll have the opportunity to enjoy the many activities at Opryland.

The hotel is magnificent, with acres and acres of gardens, waterfalls, fountains, "dancing waters", restaurants and shops - all under roof. The problem won't be finding things to do, but which ones to do first! If you go off property, the choices are even greater.

Sunday will follow the same schedule as Saturday, giving you the time for another fun-filled day or if you must, catch an early flight home.

Since the middle of March is such a busy time, with spring break. Save money three ways - advance register for this tutorial prior to February first, and make your hotel and airline reservations early.

It may be possible to raise the block of rooms at Opryland (now set at only 25) if you make a reservation before Feb 15. After that the \$135 rooms will only be space available. Our code at the hotel is AOCP-96 for that rate. Their telephone number is 615/871-7700.

Opryland is a very casual hotel. For the men, there is no need to bring suits. A sport jacket and slacks will suffice anywhere. For the ladies, the same advice - casual! This is a time to relax and enjoy.

The airlines usually require a 21 day advance purchase. Planes are more crowded than they used to be, with economy seats selling out fast. Since Nashville is a popular destination, book early for choice arrivals, departures and prices!

Registration for the tutorial was above average. Attendance at the meetings was way above average. The faculty and their choice of topics attained a new level of excellence.

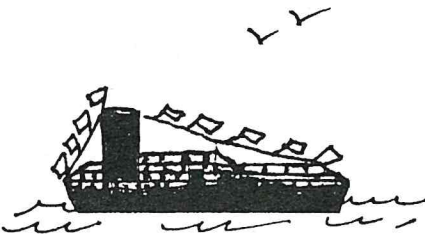
Opryland was its usual enchanting setting, with miles of spectacular garden displays - and miles of walking, getting from one end to the other. It was not a meeting for the faint at heart, and comfortable walking shoes were the order of the day. Thanks again, Dr. Gray - it was a great meeting!!

At this time, there are four meetings in the planning stage. The next one on the calendar is the Annual meeting, to be held in Las Vegas NV. The dates for this meeting are October 7 - 11, 1996. Please note, the AOA has planned this to start on and General membership meetings will occur on Monday. Didactic sessions will begin on Tuesday morning, with the Awards dinner Tuesday evening also. Again, didactic sessions will start again Wednesday morning, (no formal college luncheon this year) and conclude with the slide seminar format on Thursday.

MARCH '98

Still wondering about that ship? It's MEETING # FOUR. "Yo ho ho, and a bottle of rum!"

The Board at its last meeting approved that the MARCH '98 Midyear Tutorial be a four day, three night cruise to the Bahamas!

What a glorious way to spend a long weekend while your poor counterparts are suffering with the long, bitter cold days of winter. It makes jealousy and envy take on a new meaning.

"Yo ho ho" continued. . . To the first-time cruisers, an activity such as this requires long-term planning. Although there are many cruise lines, because of exceptional dollar value, bookings need to be planned far in advance.

The ship will leave (probably the Port of Miami) on Friday evening and return the next Monday. At this early stage, I expect the itinerary to include Nassau one day and a private island the next day.

Shipboard activities are nearly too numerous to name, in case you think you'll be bored. To name a few, there is a pool/pools, exercise classes (to help work off any one of the ten meals available each day, including the magnificent midnight buffet), ice-carving demos, bingo, and horse races.

Continuing, there is the Captains Cocktail Party, shopping, a library, galley visit, movies, shopping, bridge/navigation visit, fruit/veggie carving demo, shopping, a casino to show off any gambling skills, and, then, a few stolen hours for you to squeeze in - the purpose of all this - CME CREDIT!

A nominal registration fee will be charged in order to contain costs, with most or all of the faculty as college members. It is expected that the same high quality didactic sessions will continue. CME hours will be scheduled so as not to be in conflict with trips ashore or heaven forbid, any meals!

The negotiations will be for a block of cabins, at a group rate. Hopefully, all cabins will be "outside cabins" (porthole or window), on the same deck. Rates will be determined two ways, with an add-on air/sea package including air and ground transportation, or cruise only. The charge will be per person, with double occupancy of cabins. I will also investigate single occupancy and third/fourth occupancy of cabins.

A cruise is an "all-inclusive" event. This means all meals, aboard ship service, planned shipboard activity, music, dancing/people watching, and gala staged evening entertainment in the theater or any number of lounges on board. The only out of pocket expenses would be of a personal nature, e.g., drinks purchased on board, gift items, gratuities, photographs, etc.

To give you some idea of costs - and at this time it's a ballpark figure, I have some information that is in the range of \$400 per person, double occupancy for CRUISE ONLY. An add-on for the air/sea e.g., from Phila would be \$300pp, from Chicago \$375pp, and \$425pp West Coast, plus prevailing port charges.

At present I am looking at two cruise lines, Royal Caribbean (RCCL), and Norwegian (NCL). Either is a quality line. Please understand, any monies are submitted to the cruise line, not held with college funds. A cruise line cancellation policy is in effect which allows full refund within its published time frame. Travel insurance is also available.

Even at this early date, space availability is a major consideration. March is a peak cruise season. Since ships now advertise as having conference and/or meeting space facilities, more and more groups are planning "seminars at sea" which is an ideal way to meld business and pleasure.

Now, I need your cooperation. . . since this is something that does require an exceptional amount of planning, I want to do everything in my power to avoid any future disappointment.

The next step will be to determine a date. At this point I'm looking at mid March, maybe the 6th, 13th or the 20th. The Easter/Passover holidays are in April.

Once a commitment is made, most likely a deposit will be needed to confirm your space. I have to make a commitment for a block of cabins as, the number I settle upon, will be the number of cabins available at these rates - period!

As a comparison this year, figuring on an average, Opryland versus a cruise, hypothetically, (as a couple) there were two plane tickets at \$350 each, registration \$300, two nights at the hotel at 160, transportation airport/hotel/airport \$30, dinners Friday and Saturday (4x \$17 - did you really get away that cheap?) for a total \$68, two guest breakfasts \$12, four lunches \$35 and no entertainment, comes to a total of \$1465. A seminar at sea would cost about \$150 more. . . with more than double the fun!

Please contact me at the very earliest time possible with your intent to participate, so I have an idea whether to block 15 cabins, 25 or 40. I don't want to pick 15 when double that amount would like to join in.

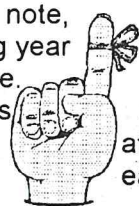

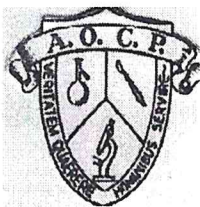
