PRESIDENT'S MESSAGE

Dear Colleagues,

The American Osteopathic College of Pathologists Board of Governors met in St. Louis, MO on Saturday, March 21, 1998. This letter is to inform you of the activities of the Board and the outcome of the meeting. Most of the focus of this meeting was centered around finances and the questionnaire which was sent to the membership some months ago.

As you know, the purpose of the questionnaire was to ascertain the membership's feelings concerning the future direction and activities of the College. Your responses were helpful, thoughtful, timely, and certainly appreciated. Your suggestions and comments relative to future direction and purpose were taken into consideration in our discussions.

Before I cover the actions taken by the Board at this meeting, I would like to summarize the results of the survey of the membership. A total of 57 responses were received. When asked about attendance at meetings: 57% said they attend the annual meeting sometimes; 35% said they usually attend; 21% said they never attend. On the other hand, 61% said they attend the midyear sometimes, 8% said they usually attend and 28% said they never attend.

Meeting location (66%), program content (48%), speaker quality (42%) were the primary factors that appear to determine attendance at these meetings. Registration cost, hotel cost, travel expense, and coverage were cited by 30%-35% as factors that influenced their attendance at American Osteopathic College of Pathologists meetings.

48% of the respondents preferred only one meeting per year and 18% preferred two meetings per year. Of those preferring only one meeting per year, 52% preferred to have the annual meeting only, 12% preferred to have the midyear meeting only, and 6% had no preference.

89% of the respondents use this college for CME's for American Osteopathic Association certification. Interestingly, 66% use ASCP meetings as a source of CME credit, 90% use hospital activities, 72% use

other advertised courses and 54% uses state society meetings for the purpose of obtaining CME credit.

The questions regarding computer access were also interesting. 70% of the respondents have access to the internet and 56% were interested in the development of a CME web site. 47% were interested in a slide seminar web site.

In the area of recertification, 63% said they would attend such a course provided by the College. The majority of respondents felt that such a course should be held at the annual meeting and cover multiple topics. 56% believe that the College should develop a course for recertification using both DO and MD speakers.

The comments and suggestions provided by the membership were useful in addressing these and other issues. The following is an outline of the Board of Governors response to the questionnaire:

- 1) A motion to discontinue the midyear meeting and hold the annual meeting only was made, seconded and passed.
- 2) A motion to investigate the development of a CME web site was made, seconded and passed.
- 3) A motion to investigate a means whereby the American Osteopathic College of Pathologists can work with the American Osteopathic Board of Pathology to develop a CME review course for the recertification process was made, seconded and passed.

Also discussed, was the fact that the College often loses money on its annual programs presented at the American Osteopathic Association convention. Concerns regarding costs for attending the annual meeting were also expressed.

The outcome of discussion that centered around these topics resulted in the motion that the dinner at the annual meeting be discontinued and, in its place, a small reception be held in the suite of the outgoing president. The motion was seconded and passed.

I believe the Board of Governors, at this meeting, has begun the process of addressing the current and future needs of the members of the College. The members of the Board and I will certainly appreciate your ongoing input, (comments and suggestions) as we move ahead in a changing medical environment.
